# Membership

**Corporate Membership:** This category is designed for those members whose dues are met by their employing organisation, which is actively engaged in, or supports the research enterprise. The maximum number of voting members in each employing organisation under this category is twenty (20), but this does not exclude the employing organisation from identifying further non-voting members.

Individual Membership: This category has two tiers.

#### Tier 1: Standard Individual Membership

This category is designed for individuals who are employed or active in the field of research management and/or administration at any level and with any sector of the research community. Each individual has voting privileges of the Society.


#### Tier 2: Small Organisation Membership

This category is designed for small organisations such as Medical Research Institutes, Government Organisations and Cooperative Research Centres, and offers a 10% discount on the Standard Individual Membership rate when 6-10 members at the same organisation pay their membership fee on a single invoice.

Each Small Organisation Member under this category has voting privileges of the Society.

Retired Membership: This category is designed for current members who have retired from the research management sector but wish to remain a part of the Society.

As at 30 June 2015, the Society had a membership base of 2123 members. The distribution of our members is summarised in Graph 1 below:

# Management and Structure of ARMS

ARMS is the professional society for specialists in the management and administration of research. Our membership spans Australia, New Zealand and the Pacific Islands, Papua New Guinea, and Singapore.

In June 2015, the ARMS Executive approved the establishment of a Chapter in Tasmania which will become the 9<sup>th</sup> Chapter in the ARMS community. The Tasmanian ARMS members are to be congratulated on their commitment and energy for advocating this new initiative. Operations of the Victorian Chapter will not be affected with this change in structure.

The membership of the Society draws from various areas of the research management community, including universities, research institutes, government departments and private organisations.

ARMS is an incorporated association formed in 1999. It is a non-profit organisation governed by an approved ARMS Constitution and operationalised by a set of by-laws.

#### Appointment of Office Bearers and Committee Members (ARMS Executive)

The Executive is the governing body of the Society and it controls and directs the affairs of the Society, including its committees and publications. The Executive determines the Society's promotions, policies, and strategic planning, and it evaluates the Society's progress towards achieving its mission and goals. The Executive has statutory responsibility for all ARMS activities throughout the Society.

The Executive currently includes five office bearers - President, President-Elect, and Immediate Past President, who are all appointed on a one-year term, and Secretary and Treasurer, who are appointed on a two-year term. The Executive also includes four general Committee Members who are appointed on two-year terms. The President of the Society is the Chair of the Executive. At the ARMS AGM held on 18 September 2014, the following amendments to the Presidential roles were approved:

- The term of the **President** was extended to two years and the role of **Immediate Past President** was phased out. Accordingly, a President-Elect will be elected the year before becoming **President**, then take a two year Presidential term but have no term as **Immediate Past President**; and
- In those years where there is no President-Elect, a **Deputy President** be appointed by the Executive from the nonoffice-bearing members of the Executive. The role of Deputy President is to stand in for the President when he or she is absent. Clause 7.2(e) of the amended constitution outlines the transition from the current arrangements.

The Committee endorsed that these amendments would take effect for future President-Elect appointments from 2014/2015 onwards.


#### Induction

All new office bearers and committee members meet with the President and the ARMS Chief Operating Officer to be briefed about their role and their responsibilities within the context of the strategic direction of the Society. Each new member is given an Induction Handbook which includes an overview of the operations of the Society, its governance structure and policies.

#### Organisation

To further its mission, ARMS is organised into Chapters, Standing Committees and Special Interest Groups which may change over time, subject to the needs of the Society and the approval of the Executive. These structural groupings report to the Executive and are directed by the strategic goals and operational principles outlined in the ARMS 2020 Strategic Plan.

# **ARMS Strategic Plan**

The rapid professionalisation of ARMS is necessary if ARMS is to achieve its strategic objectives, but also creates new challenges. The Executive is very aware that as ARMS grows, we need to evolve from a mostly volunteer society to a more complex mixed model, one with a high functioning professional office with a management and operational function, and one that strongly supports the volunteer roles upon which the society depends. The Executive will be undertaking a governance review in November 2015. Members will be consultated and updated on progress.

## Our Mission

#### ARMS is an international organisation dedicated to:

- The professional development of research managers and research administrators; and
- The promotion of the profession of research management; and
- the enhancement of the research enterprise.

#### The Society shall fulfil its mission through:

• The establishment of a strong and effective professional network of research managers; and

- research administrators at all levels and based on a variety of settings through personal relationships, presentations, formal and informal meetings and publications;
- The development and promotion of professional standards for research management and research administrations in the region consistent with international best practice; and
- The improvement of the interface between research and its management; and
- Such other activities as the membership shall adopt.

## Our values

- A stronger, vibrant research sector in the region;
- High standards of research governance, including the protection of integrity and ethics of research; and
- The profession of research management as integral to the research endeavour.

Following a successful launch in September 2013, the Foundation Level Accreditation Program continued to grow during the financial year 2014/2015. By June 30th 2015 there had been approximately 880 module registrations with 79 people completing the full requirements for accreditation as Accredited Research Managers (Foundation). The names of those achieving this distinction are listed at the conclusion of this update.

Each ARMS Chapter offered one or more modules during the reporting period. Of particular significance:

- The WA Chapter arranged delivery of all Australian based Foundation modules during July 2014 with more than 40 persons attending at least one module and approximately 150 module registrations in total. Twenty eight members from the WA Chapter went on to complete full accreditation requirements and were subsequently recognised for their achievement at a Chapter event held on the 17th of April 2015.
- The Singapore Chapter hosted module E, Understanding Research and Researchers, during their inaugural Chapter event in November, 2014, with 48 persons attending. The New Zealand Chapter hosted their first Foundation Level modules during December 2014, comprising module B: National Research and Innovation System in New Zealand and Module H, Pre-award Grants Processes.

By the end of June 2015, the ARMS Accreditation Council was in the process of reviewing eight of the existing Australian Foundation Level modules: Module C: Legislation as it affects Research in Australia; Module F: Research Ethics; Module G: Research Integrity; Module I: Post-Award Processes and Module J: Research Data and Analytics. The Council is currently reviewing Module A: The National Research and Innovation System in Australia; Module E: Understanding Research and Researchers and Module H: Pre-award Grants Processes. The Council is also overseeing the development of two Singapore specific modules, K (An Overview of the Singapore National Research and Innovation System) and L (Legislation as it applies to Research in Singapore). These will be presented for the first time at the ARMS 2015 Annual Conference in Singapore. A major outcome during the reporting period has been the acceptance of a model for the Professional Level Accreditation Program. The development of the Program was approved by the ARMS Executive at its meeting of September 2014 with a discussion paper circulated to all members for input during March/April 2015. The model has benefited from the input of an ARMS Member Reference Group comprising experienced research managers, mid-career research managers and representatives from Australia and New Zealand and the medical research fraternity. The ARMS Professional Development and Accreditation Committee has overseen development of the model in conjunction with the Accreditation Council and the ARMS Executive.

The Professional Level Program will be launched in September 2015 and contain a core residential program looking at leadership and management skills applied in research management settings, several electives containing advanced knowledge in specific research management topics and a workplace based assignment. The program will be supplemented by individual mentorship of candidates and group learning via monthly moderated teleconferences. It promises to be a very exciting and relevant program for midsenior research management personnel.

It must be acknowledged that the Accreditation Program relies on the collegial spirit of many high quality and willing ARMS members, including those serving on the Accreditation Council and other related committees, ARMS Training Fellows who deliver Foundation modules throughout the ARMS constituency, case study assessors, module reviewers and the Professional Accreditation Reference Group.

#### ARMS Accreditation Council

The Accreditation Council plays an important role in the accreditation process, overseeing quality standards of module content and delivery agents and providing a measure of independence from the ARMS Executive over accreditation recommendations.

# Chapter Highlights

#### ACT Chapter

The ACT Chapter has a firm commitment to addressing important issues relating to the current Australian research agenda, while at the same time delivering programs that are of direct relevance to research administrators and researchers. The Chapter hosted three events in 2014/2015: Measuring the Value of ERA; The Nuts and Bolts of Research Administration; and Out of the Comfort Zone: Seeking Alternative Sources of Funding. Due to its location, the ACT Chapter was able to secure high profile speakers, including Professor Aidan Byrne (CEO, ARC) and Prof Tony Peacock (CEO, CRCA).

#### New South Wales Chapter

In April and May 2015, the NSW Chapter committee held an expression of interest for new committee members and has welcomed aboard from 1 July: George Carayannopoulos, Debbie Docherty, Amanda Elliott, Ross Hill and Boris Sarcevic. The new committee met at UTS in late June and plans are underway for events and workshops for the second half of the year, including a professional development workshop on Defence Trade Controls, provision of two accreditation modules in August, and a guest speaker event for the end of the year.



The Chapter also farewelled four committee members: Gary Long, Elianne Renaud, Erin Semon and Casey Windrum. We thank them for their tremendous efforts and input into the committee and its work.

The NSW Chapter held a range of successful events during the 2014/2015 reporting period. One key event occurred on 31 July and 1 August 2014, combining accreditation modules and professional development workshops. The first day involved the presentation of Module A: National Research and Innovation System in Australia by Ms Janice Besch, and Module G: Research Integrity by Dr Ted Rohr. The second day offered two half-day workshops, attended by 50 participants. The first workshop was on Understanding contracts: Reading, Interpreting, and Identifying Risks in *Research Contracts and Agreements*, with hands-on input from Mr Warwick Dawson, Ms Ann-Marie Heinrich, Ms Anita Kelly and Mr Geoff Shelley, as participants worked through a range of issues around reading and understanding contracts. The second workshop covered *Grant development: Helping* Academics to Produce Strategic Grant Applications, with expert advice from Ms Merrilee Robb, Dr Andrew Black and Emeritus Professor Mark Wainwright.

Another well-received event for the year was *Governance Approval for an Investigator-Initiated Clinical Trial: a Scenario-Based Workshop*, held on 23 April 2015. Attendees heard from Dr Gordon McGurk, of the NHMRC, about the changing landscape for clinical trials in Australia. They then spent the morning working through a real-life scenario that illustrated a host of difficulties that can occur in preparing for a clinical trial.

#### New Zealand/Pacific Islands Chapter

The New Zealand and Pacific Chapter rolled out the Foundation Level Accreditation Program with two modules presented in December 2014 at Unitec in Auckland: The New Zealand specific Module C: Legislation as it affects Research and Module H: Pre-Award Grants Processes. The module presentation was aligned with the annual face to face meeting of the Chapter. Two of the Executive Committee, the President, Dr Simon Kerr and President- Elect, Dr Janice Besch attended the meeting in Auckland. The Chapter Co-Convener, Dr Chris Kroger, was invited to present on ARMS at the Annual University Research Offices New Zealand Conference, and to the University of Auckland Research Office. At ARMS 2014 in Canberra, the Chapter met for a relaxed member breakfast to support networking among New

Zealand members. The Chapter submitted a bid to host the 2017 ARMS conference, proposing Wellington, New Zealand as its location.

#### Queensland/NT/PNG Chapter

The ARMS QLD/NT/PNG Chapter enjoyed a successful one day workshop on 30 June 2015 themed "Best Practice Support for the Multidextrous Academic".

Speakers included the Assistant Director General of Science within Queensland Government discussing 'Building a vibrant research sector in the region' and Professor Patsy Yates - a leading cancer/palliative care researcher presenting her 'Reflections of a Multidextrous academic'. There were presentations on 'Engaging with Government' and 'Tools and Practices to support the Multidextrous academic' focusing on data management and metrics.

Six breakout sessions were held covering both distinct work areas - ethics & integrity, HDR support and major grant rounds debrief; alongside discipline specific breakouts for HASS, Health & Medical and Science & Engineering.

From 61 registrants, 32 returned feedback forms with 100% providing a response of Strongly Agree/Agree to the statement "My overall experience at the workshop was great, and I would recommend similar events to colleagues" and 94% providing a response of Extremely Useful/Very Useful to the question "How useful was the content of presentations to your job role". So overall a very positive day – thank you to all who attended!

#### Singapore Chapter

The major highlight for the Singapore Chapter was the event "Empowering Research Administrators for Excellence" held on 21 November 2014. The event consisted of two components, a Research Administration Conference in the morning and ARMS Accreditation Module E: Understanding Research and Researchers in the afternoon. Over 90 ARMS members in Singapore and representatives from research organisations and funding agencies attended the event. At the conference, the Chapter Convenor Professor Michael Khor and Ms Maria Zollo, Chief Operating Officer of ARMS introduced ARMS and the ARMS Singapore Chapter to the audience. Guest speakers from various organisations shared their experience and insights on research administration. There were presentations on the latest intelligent tools to empower research administrators in their daily work and an interesting and interactive Discussion Forum "**Research Administration Excellence**" where the audience and panel members discussed and exchanged ideas on a variety of issues relevant to research administration excellence.

The Chapter also organised a Beer & Pizza get-together on 23 April 2015. Representatives from Elsevier, Nanyang Technological University, National Institute of Education, Singapore Health Services Pte Ltd, Thomson Reuters and Yale-NUS College enjoyed networking with fellow research administrators, exchanging ideas on research administration, making plans for the Chapter activities in 2015 and formulating action plans for the ARMS Conference 2015.

#### South Australia Chapter

The South Australian Chapter is strongly supported by our corporate members; University of Adelaide, University of South Australia, Flinders University and CSIRO; with individual members representing much of the profession in the State. The SA Chapter Committee meets every two months, and aims to provide a range of professional and social activity for Chapter members. Over the past year the Chapter has hosted two networking and social events, three accreditation training days and a combined AGM andsocial event. The chapter also co-hosted a clinical trials workshop in association with AusBiotech.

Of particular note, our Bibliometrics training days exceeded capacity, with participants from interstate and overseas attending. These sessions have proven so popular that additional dates have been booked, and at time of print, have sold out. Special mention must go to Adam Finch at CSIRO for presenting these specialist information sessions.

The Chapter Committee will continue to provide our members with accreditation opportunities and networking events, seeking opportunities to partner with congruous organisations to further the ARMS outreach.

#### Victoria/Tasmania Chapter

The Chapter delivered two exciting professional development workshops. The first, titled "Show me the money! Research Management & Finance" attracted a crowd of research managers and administrators operating in the areas of grants/ contract/donation funding, financial reporting, financial compliance and/or budgeting. Presenters included Jan Thomas from The University of Melbourne and Heather St John from Monash University and Jim Lewis.

The second professional development session "Use of Social Media Tools in Research and Research Administration" was held at Monash University, Caulfield Campus. It featured presentations from Jonathan O'Donnell, RMIT University; Tseen Khoo, Lecturer in Research Education and Development at La Trobe University; Carol Saab from the Social Digital and Media Team at CSIRO; and Jennifer Bishop - Director, Content and Copy.

#### Western Australia Chapter

The WA Annual General Meeting and end-of-year networking function was held in December at the Harry Perkins Institute of Medical Research and was a great success.

The Accreditation Program was successfully run in July 2014 and resulted in 30 members becoming ARMS Accredited Research Managers. A graduation ceremony and network function was held in April to present the graduates with their certificates. The event was attended by 35 people including distinguished guests the Deputy Vice-Chancellors of Research and the Directors of the Research Office from WA Universities.

A workshop on Social Media Tools for Research and Research Management, presented by Dr Tamika Heiden, was held in February 2015, with 16 people in attendance. # Standing Committee Highlights

#### International Committee

The International Committee develops strategies and implement initiatives to increase the international presence of ARMS and raise awareness of international professional development and collaboration opportunities for ARMS members.

The International Committee commenced 2015 with a face-toface meeting in February in Melbourne and has subsequently met monthly via teleconference throughout the year.

Priorities identified and progressed by the Committee include a proposal:

- Jointly with the International Collaborations Special Interest Group, for a think tank with government and country representatives addressing the barriers to, and ways forward, for research across national boundaries; and
- For joint Fellowships with the US research management peak body, the National Collaboration of University Research Administrators (NCURA). Ratified by the ARMS Executive, this initiative will be announced as part of a suite of international professional development opportunities for ARMS members in the 2015-2016 year. We are grateful to the proactivity of Julie Ward on this front.

The International Committee is the primary representative for ARMS on the International Network of Research Management Societies (INORMS). Together, INORMS represents a global membership of approximately 20,000 people and 250 organisations. The INORMS Working Group has representatives from the major organisations, of which ARMS is one. As our membership spans three countries – Australia, New Zealand and Singapore – ARMS is perhaps the most international of all research management associations amongst the group. Through the Group, the International Committee became aware of the size, scale and activities of all known associations internationally and this information is being progressively shared through the ARMS Newsletter. A more focussed survey on professional development opportunities across associations is now in its planning phase, with a view to identifying touchstones for international collaboration on this front.

#### Marketing and Communications Committee

The Marketing and Communications Committee is responsible for the promotion and reputation of ARMS through quality and professional communications. Members of the **Marketing and Communications Committee** during the 2014/2015 reporting period were:

The Committee commenced 2015 with a planning meeting at UNSW in Sydney in January where it was decided to divide Committee activities into two operational streams: the Social Media Sub-group and the Marketing Material Production Sub-group. The Marketing Material Production Sub-group then met at the end of January at the University of Melbourne to structure its activities. The Social Media Sub-group identified the main media of interest as Facebook, LinkedIn and Twitter and assigned responsibilities for each of these media to re-build and promote among ARMS members.

The Committee has worked closely with the ARMS Executive Office on key ARMS initiatives, including:

- Enhancing the content and look of the monthly e-newsletter;
- Increasing social media presence, with more prolific use of LinkedIn, Facebook and Twitter;
- Reviewing marketing collateral to foster the profile of the Society; and
- Promoting the regular dissemination of information about the Society in news releases and other media.

Many of these initiatives will continue to be developed over the coming year.

The most significant body of work for the Committee this year, however, was the ARMS Web Platform Project. As identified by the ARMS Executive the Society's website and management system required a significant overhaul. The Marketing and Communications Committee developed a project specification brief on behalf of the Executive which went for tender. A working party consisting of a selection of members of the Executive and the Marketing and Communications Committee interviewed two short-listed tenderers and the ARMS Executive approved the appointment of the successful company, Eyedea, to carry out the project for implementation by end of August 2015.

A Web Platform Project Working Party was established to help the Committee to review content of the current website, re-write to suit the new website, and to conduct user testing. Members of the Working Party include:

#### Policy Standing Committee

The Policy Standing Committee is responsible for developing and implementing policy and advocacy strategies to ensure ARMS remains the peak body for the profession in the region. The Committee also coordinates the ARMS response to relevant government policy documents and reviews; and contributes to annual peak body activities such as the ARC/NHMRC Research Administrators Seminar and the University Research Office New Zealand (URONZ) meeting.

The Policy Standing Committee comprises the President, Dr Simon Kerr, President-Elect, Ms Janice Besch and Immediate Past President, Dr Gayle Morris. Subject specialists are coopted as required.

The Committee coordinated the ARMS submission to the Senate Economics Reference Committee (SERC) in relation to the Inquiry into the Australian Innovation System which was submitted on the  $31^{st}$  of July 2014. The Society has since been invited to attend a hearing on the Inquiry in Melbourne on the  $3^{rd}$  of August 2015.

The Policy Standing Committee also coordinated two round table sessions at the 2014 ARC/NHMRC Research Administrator's Seminar in Canberra. Input was sourced from the University Research Director's Special Interest Group on relevant roundtable topics which were providing and managing feedback from grant rounds and managing partner organisations. 



### Strategic Partnerships

#### ARMS Collaborates with the Australasian Ethics Network

The Australasian Ethics Network (AEN) is a professional network of members and administrators and researchers from human research ethics committees or involved in human research. The AEN started as a network of NSW Human Research Ethics Committee Chairs and administrators in 1994 and has since evolved into a strong network with a broad audience and geographic coverage. AEN conferences in recent years have attracted 300 plus attendees and are now a regular and well-established event.

The relationship between ARMS and the AEN has been growing steadily and has resulted in an agreement on operating principles in January 2015. The AEN does not have its own legal structure and now operates as a stream of the ARMS Ethics & Research Integrity Special Interest Group (SIG). This collaboration with ARMS provides the AEN with a governance structure and operating support beyond the capabilities of a sole network. The AEN Advisory Group steers the activities of the AEN and works with the ARMS Executive and the SIG. The functionalities of the new ARMS web platform will open exciting opportunities for AEN members to communicate with each other. The next AEN Conference is expected to be held in Adelaide in late 2016.

#### ARMS Collaborates with the Australasian Research Training Network

The Executive gave provisional approval in June 2015 for an alliance with the new Australasian Research Training Network (ARTN). The formation of the ARTN and the agreement with ARMS is the culmination of discussions following a survey of senior higher degree research administrators at each member institution of the Australian Council of Graduate Research (ACGR – previously DDoGs).

The functions of the ARTN are to:

- Provide a forum for discussion of research training issues and the administration of research training throughout Australasia;
- Provide opportunities for professional development, networking and peer support;
- Support the coordination of regional and international conferences relevant to the needs of its members;
- Provide an avenue for the publication and distribution of relevant professional material including occasional papers;
- Participate in appropriate local and regional activities; and,
- Make recommendations for strategies that support the operation of research training administration.





## Expanding our International Networks

ARMS is a member of INORMS, a network formed in 2001 to bring together research management societies and associations from across the globe. Its purpose is to enable interactions, sharing of good practice, and joint activities between the member societies, to the benefit of their respective members.

#### **Our Finances**



Building on the success of my inaugural year in this role, we are continuing to improve the sophistication of our financial management processes and associated reporting. There is an unavoidable learning curve in any new role however, as ARMS Treasurer, it seems like the learning never stops, particularly as ARMS continues to grow and expand the breadth of its activities throughout the region!

ARMS operations are largely funded from membership fees and any profits arising from the annual conferences – this currently includes our flagship ARMS conference as well as the Australasian Ethics Network (AEN) conference facilitated by our Ethics and Integrity Special Interest Group, both which saw increased profits in this financial year.

Any income we generate is then reinvested into key strategic priorities to progress the aims and objectives of the Society and for the benefit of members.

A major initiative, in this regards, has been the establishment and ongoing development of the ARMS Accreditation Program. This financial year has seen an over \$30k profit for the Society from this program, which is \$8k improvement on the previous financial year. It's great that we are starting to recoup our initial investment outlay in this program.

There have also been other costs incurred associated with the development of the Professional Level program that are reflected in the increased costs incurred by the Professional Development and Accreditation Program Committee.

We also increased our investment in our Marketing and Communications Committee which progressed a number of significant initiatives this year, including the rebranding of our logo and establishment of our new and improved website.

In order to support these and other new initiatives, we established an Administrative Officer position in our Executive Office and, given we now have two staff members, also created a budget for professional development costs in support of our valuable team.
